In this context, these guidelines are once again circulated to you for further circulating the same to all the schools functioning under your jurisdiction for strict compliance and adherence at school level in a time bound manner and also ensure periodic inspections of all schools, so that these guidelines are strictly adhered to at school level Apart from above this office has also issued some separate instructions on food safely and hygiene to you from time to time which are also again circulated for circulating the same to all schools for strict compliance.

In view of the above, you are therefore directed to issue all these enclosed guidelines and instructions on food safety and hygiene for School Level Kitchens under Mid Day Mal Scheme for strict compliance and adherence at school level and ensure periodic inspections of all schools from time to time. In this regard, it is also pertinent to mention here that all the Mid Day Meal Cook cum Helpers / Mid Day Meal workers may be directed and advised that before preparing the meals in the schools under Mid Day Meal Scheme all the cooking utensils as well as equipments especially the whistle and safety valve of cookers be properly checked and LPG cylindees and regulators may also be properly switched off after preparing the meals in order to avoid any untoward incidents under the aforesaid Scheme at school level at any time.
