As you are well aware of the CBSE guidelines of tobacco free education Memo: institutions & Section 6 (a & b) of the COTPA Act 2003 which is , Section 6-Prohibition on sale of tobacco products to minors-

- (a) No person shall sell, offer for sale, or permit sale of, cigarette or any other tobacco products to minors&
- (b) in an area within a radius of one hundred yards of any educational

In this connection, you are hereby directed to issue necessary instructions to all the Incharge of educational institutions under your control to act immediately without any further delay against all the violations of section 4 & 6 of the COTPA. If there is a shop selling any tobacco products within 100 yards of any education institution then responsibility to act immediately as specified in the COTPA lies with the Incharge of the Educational institution. They can seek the help of the local police officer of the rank of subinspector & above for taking further necessary action They may also refer the 'Law enforcers guidelines' released by MOHFW of GOL

All the orders / instructions against the violation of section 4 & 6 of th COTPA shall be maintained / obeyed in letter & spirit.
